With this acquisition Skaylink plans to further expand its service portfolio in the area of AWS, as this represents the next step for Skaylink on its way to becoming the leading provider of managed cloud services for enterprise customers and medium-sized businesses in the DACH region. The founders and management team of root360 will remain on board and will invest in Skaylink. Further financial details of the transaction were not disclosed.

Root360 GmbH, based in Leipzig, Germany, was founded in 2015 and is one of the leading providers of AWS platform and cloud environments in Germany. The company focuses on the implementation and operation of web applications, portals, platforms, e-commerce, content management and SaaS (Software as a Service). root360 is a certified AWS Advanced Consulting Partner, with the Digital Customer Experience Competency (DCX), as well as an AWS Solution Provider. More than 100 clients, including renowned companies and brands such as Steigenberger, Siemens, INTERSPORT and TUI rely upon root360's services for their business-critical web applications, SaaS solutions or online shops in the AWS cloud.

In 2020, the private equity investment group Waterland acquired a majority stake in Skaylink which today employs a staff of more than 400 in Germany, Romania and Brazil. In the future, Waterland will continue to support Skaylink's growth – organically via gaining additional share in the growth market for cloud services and through targeted acquisitions.

Waterland has extensive experience in the fields of digitalization and modern IT infrastructure through its investments in several European countries. In the German-speaking region, Waterland has already invested in companies such as netgo (IT provider), Serrala (payment



software), Netrics (cloud and ICT services) and GOD (enterprise IT and software solutions) as well as Enreach (unified communications solutions), amongst others.
